### **TERMA AND CONDITIONS FOR WW.ABAMX.COM**

#### **1. OWNERSHIP AND USE RESTRICTIONS**

**Welcome to ABAMX.com, the official digital platform of the Mexican American Basketball Association (ABA Mexico). ABAMX.com is operated by ABA TV Media Network, LLC ("ABAMX TV"), ABAMX TV, LLC ("ABAMXTV"), ABAMX Properties, Inc. ### **19. CHOICE OF LAW; FORUM SELECTION**

**These Terms of Use and your use of ABAMX.com shall be governed by and construed in accordance with the laws of Mexico, without regard to its conflict of law principles. Any legal action or proceeding arising out of or related to these Terms of Use shall be brought exclusively in the competent courts located in Mexico.**

### **20. INJUNCTIVE RELIEF**

**would not be an adequate remedy. In such cases, the Operator may seek injunctive relief or other equitable remedies to prevent or restrain the breach.**
